1. Introduction

AVATAR is a project led and coordinated by EUNDO LIMITED (EUN) and with partner the German Oncologoy Center (GOC). The nine (9) month project commences on 01/05/2023 and will be completed on 31/01/2024. The purpose of the project is to demonstrate the principle of generating synthetic healthcare data that mimic the statistical properties and attributes of real data. Although they mimic the real data, the synthetic data are not traceable to real data. Since they are not traceable to actual patients, privacy is preserved. The synthetic data can be used for training of healthcare professionals and also for training machine learning algorithms. So there is significant value to this data without compromising patient privacy.

The main objectives of work package (WP2) are to disseminate the knowledge, results, methodology and new techniques to scientists and engineers in the field of digital health. WP2 also informs the public and other stakeholders and innovators as a whole to generate interest in the project activities and results. Another important objective of WP2 is to secure subsequent private funding to: a) ensure the continuation of this project (to reach a higher TRL) and b) support the sustainable and continued collaboration between the partners.

1.1 Purpose of the Document

The purpose of this document is to plan the communication and dissemination activities for the duration of the project. This is done at the beginning of the project and takes into consideration any upcoming opportunities for dissemination. The plan was discussed during the kick-off meeting at GOC on 04/05/2023.

2. Dissemination and Communication Plan

2.1 Methodology

During the kick-off meeting it was discussed that for some of the conferences that would be appropriate there is not enough time to complete the research and submit an abstract. So, for the time being there are no plans to attend any international/European conferences. The consortium will be monitoring for any new opportunities during the project and make the necessary adjustments. During the kick-off meeting it was discussed that it would be very valuable to engage policy makers and key stakeholders in the area of data privacy especially in healthcare. Those would be: 1. The national eHealth Authority 2. Cyprus National Bioethics Committee. The engagement is to occur towards the end of the project (December 2023) so that we can show results.

This will be one of the major scientific achievement of the project. Real data has been used for a peer review publication for GOC. EUN will use that data, generate synthetic data and then compare the conclusions drawn from them to the real data. The peer review publication planning and draft ideas will be completed by the project end.
